

Suggested Minor Modifications to NHDC's Submission Local Plan 2011-2031

The List outlines our suggested minor changes to update the document, improve clarity and presentation. These are generally regarded as textual and grammatical corrections; re-phrasing or limited new text to add clarity; or updates to figures and references which are necessary due to alterations which have been made elsewhere or for which new information has come to light.

In our opinion these changes, when verified and applied by the Council, would assist the Inspector in understanding the Council's position. From the viewpoint of accessibility they would assist participants in the Inquiry and the public at large to understand the document. They would not alter the overall impact of the Local Plan or change its direction, or adversely affect the substance or soundness of the document. We do not expect a further Sustainability Appraisal of these suggested changes would be required. However it is up to the Council to determine changes and impacts.

Policy / Paragraph: the specific policy or paragraph within the Submission Local Plan to which the change applies.

Local Plan Page: where the applicable policy or paragraph is located in the Pre-Submission Local Plan.

Proposed Minor Modification: details of the suggested change. Unless it states otherwise, where text is to be deleted it will have a strikethrough thus: ~~deleted text~~. Where additional text is proposed, it will be bold and underlined thus: **additional text**.

Reason for change: the reason why the minor change is suggested, for example to correct a typo, update text or clarify the meaning.
